CIRCULAR

All the staff and the students are requested to help us in regulating the vehicle parking in the College and Hospital campus.

All staff members and students should procure the stickers for their vehicles (at the cost of Rs.400/- for four wheelers, Rs. 200/- for two wheelers and Bicycles free).

The stickers can be had from the Secretary Office. However, it is suggested that staff should send their names and vehicle numbers through their Head of the department/ Section Head to the Secretary Office and the Secretary Office will issue the stickers department wise / section wise and the cost of the same will be deducted from the salary of the employees.

All Staff vehicles should have stickers otherwise parking contractor may not allow their vehicles in staff parking zone. All should note that from 16th August 2019 staff vehicles not bearing stickers will be charged as per rules applicable for patient's vehicles. Therefore you are advised not to put yourself into inconvenience and procure stickers before that.
